**“Re-launch of Scheme for Promotion
of Electric Vehicles (EVs) in the
State of Goa”**

The following Re-launch of Scheme for promotion of Electric Vehicles (EVs) in the State of Goa is approved by the Government and is hereby published for the general information of the public.

1. *Short title and commencement.*— (i) This scheme may be called as “Re-launch of Scheme for Promotion of Electric Vehicles (EVs) in the State of Goa”.

(ii) It shall come into force after publishing in the Official Gazette from 1st August, 2022.

(iii) The scheme shall be implemented through the Goa Energy Development Agency (GEDA) in online mode at EV portal www.goaev.in

2. *Introduction to the scheme.*— I. Goa has a vehicle density of 625 vehicles for every 100 people and is ranked 15th in the World in terms of vehicle density. Adoption of use of Electric Vehicles (EV's) for daily commute is required to achieve various goals, including improvement in air quality,

reduction in noise levels and reduction in generation of green house gas emissions.

II. Government of Goa intends to re-launch the scheme for promoting of Electric Vehicles in the State of Goa by providing incentives to build integrated infrastructure and to encourage drivers to switch to EVs for improvement of air quality and reduction of green house gas emissions.

III. The consumer has to purchase Electric Vehicle directly from authorized dealer and avail benefits from Government of Goa.

3. *Objectives of the scheme.*— This scheme is formulated with the following objectives:

(a) The primary objective is to accelerate the pace of EV adoption across vehicle segments, especially in the mass category of two wheelers, public/shared transport vehicles and goods carriers. The scheme shall seek to drive rapid adoption of Battery Electric Vehicles (BEVs) so that they contribute to 25% of all new vehicle registrations by 2024 and bring about a material improvement in air quality by reduction in green house gas emissions, reduction in noise levels and also use of fossil fuels by bringing down emissions from the transport sector.

(b) To promote the adoption of Electric two wheelers, three wheelers and four wheelers in the State of Goa.

(c) To provide financial assistance in form of subsidy for purchase of Electric two wheelers, three wheelers, four wheelers and retrofitting of ICE vehicles to EV by providing subsidy.

(d) The scheme will also seek to put in place measures to support the creation of jobs in driving, selling, financing, servicing retrofitting etc., and charging of Electric Vehicles.

(e) It is expected that the incentives provided in the scheme shall encourage

delivery service providers (e.g., food delivery, e-commerce logistics providers, couriers) to switch to using electric two wheelers.

4. *Scope of the scheme.*— The main scope of this scheme is to provide incentive in the form of subsidy to the prospective users for purchase of electric two, three, four wheelers and retrofitting of ICE vehicles to EV in State of Goa.

The Fiscal Incentives being offered under this scheme would be in addition to the demand incentives available in the FAME India Phase-II scheme of Government of India.

4.1 The financial assistance for conversion of ICE vehicles to EV will be provided in form of subsidy.

4.2 Registered owner of ICE vehicles (i.e. eligible for the EV purchase incentives) shall also be eligible for a scrapping incentives for scrapping and de-registering old ICE 2W, 3W & 4W registered in Goa.

4.3 The Financial Assistance will be provided from 1st August, 2022 to 31st December, 2024 in form of subsidy as mentioned below:-

*Scrapping benefit shall be applicable to the beneficiary purchasing new Electric Vehicle in that financial year.

5. *Eligibility and modalities for availing benefits under the scheme.*— a) Copy of the Aadhar Card issued in Goa.

b) 15 years Residence Certificate of Goa issued by Mamlatdar office.

(i) Relaxation to the beneficiaries married in Goa having Civil Marriage Registration Certificate in Goa. However, spouse must have 15 years, residence certificate issued by Mamlatdar office.

(ii) Relaxation for Government servant by producing service letter from the head of Department.

c) Tax invoice copy of the purchased Electric Vehicle.

d) Insurance copy of the Electric Vehicle.

e) Cancelled cheque/bank details.

f) De-registration certificate of the ICE vehicle by the RTO (in case of scrapping incentives).

g) The beneficiary should submit online application within 90 days of notification of this scheme for Electric Vehicles purchased prior to issue of this notification.

h) The beneficiary should submit their online application within 120 days of purchase of new Electric Vehicles after issue of notification of this scheme.

6. *Pattern of Assistance of the Scheme.*—

(i) “The GEDA shall be entitled to Government grants based on the estimate approved by the Government in the Budget Estimate during that financial year” for the scheme and will be sanctioned as per the terms and conditions laid by the Government.

(ii) The subsidy shall be disbursed in a single installment to the beneficiary concerned i.e. 100% on purchase of the Electric Vehicle and production of documents mentioned at pt. No. 5 by the beneficiaries.

(iii) The Government reserves the right to keep in abeyance, stop future subsidy and modify the financial quantum, as also the conditions of the scheme, at any point of time, to limit expenditure to the budgetary provisions made for the purpose. No claim or appeal or challenge shall lie with any authority or Court, in respect of this decision of the Government.

(iv) In case of a fraudulent claim of subsidy benefits by an applicant, GEDA would proceed to recover the subsidy amount from the beneficiary. GEDA could also initiate appropriate criminal proceedings against the defaulting applicants.

7. *Relaxation of the provisions of the scheme.*— The Government shall be empowered to relax any or all of the clauses or conditions of this scheme in genuine case(s) for sanction of the grant.

8. *Interpretation of the provisions of this scheme.*— If any question arises regarding interpretation of any clause, word, expression of the scheme, the decision about the interpretation shall lie with the Government, which shall be final and binding on all concerned.

9. *Redressal of grievances and dispute.*— Grievances or disputes between beneficiary and GEDA, if any, arising out of implementation of this scheme, shall be referred to the Secretary (NRE) to the Government of Goa who shall hear and decide such matters and the decision of the Secretary (NRE) to the Government of Goa in this regard shall be final and binding on all concerned.

Provided no grievance or dispute regarding the decision of the Government under clause 6 (iii) above shall lie with any authority or tribunal or court, in respect of the decision.

This scheme has been issued with the Administrative Approval of the Government under U. O. No. 1805/F dated 01-06-2023 and concurrence of the Finance (Exp.) Department vide their U. O. No. 8086/F dated 30-11-23.

“Revised Scheme for Promotion of Grid Connected Solar Rooftop System with Net, Group Net & Virtual Net Metering FY 2023-2026”

The following revised Scheme is approved by the Government and is hereby published for the general information of the public.

Preamble.— In the major initiative, Government of India under the National Solar Mission has set a target of 450 GW power generation through Renewable Energy in the country by 2030.

In order to achieve this magnitude of capacity, the Ministry of New and Renewable

Energy (MNRE), Government of India has notified Phase-II Solar Roof Top Scheme in which State of Goa has been allotted 20 MW capacity of Solar Energy by 2024.

Installation of rooftop solar plant on a large scale is one of the best initiatives, as in such plants, there are no requirements of land, energy is consumed where it is generated; there would be no element of transmission loss or wheeling loss and such plants would be in interest of public at large as well as State utilities. Therefore, with a view to promote large scale rooftop solar systems on private residential roofs-terraces, the Government vide its Notification in Official Gazette, Series I No. 19 dated 6th August, 2020 referred above had introduced a subsidy scheme for solar rooftops in residential sector and commercial sector. As a result of this subsidy scheme, over 100 households have taken the benefits of the subsidy scheme under which an aggregate capacity of Appx. 1 MW of solar rooftops in residential and commercial sector have been commissioned.

To give further boost for promotion of solar rooftops in the State for residential sector, it was under the consideration of the Government to rationalize the subsidy scheme to increase the scope for the benefits of the masses including implementation strategy.

1. *Short title and commencement.*— 1.1 This scheme may be called as “Revised Scheme for Promotion of Grid Connected Solar Rooftop Systems with Net, Group Net and Virtual Net Metering, 2023-2026”.

1.2 Government of Goa had notified the “Scheme for Promotion of Grid Connected Solar Rooftop System with NET Metering System” vide Series I No. 28 dated 7th October, 2021 with financial capping of 04.00 Crores on first cum first serve basis.

1.3 This scheme proposes to amend the scheme of 7th October, 2021 taking into consideration the Phase-II of Grid Connected Rooftop Solar Programme of Ministry of New

and Renewable Energy (MNRE) Government of Goa and the guidelines issued by MNRE vide O. M. No. 318/331/2017-Grid connected Rooftop dated 20th August, 2019 and OMs for admissibility of CFA for Residential Sector Rooftop Solar Project installed under Rooftop Solar Programme Phase-II and its amendment from time to time.

1.4 Upon the issue of notification of this “Revised scheme for Promotion of Grid Connected Solar Rooftop Systems with NET and Group Metering, 23”, the provisional approvals issued by Department of Electricity, Government of Goa will not be considered for registering any claim of State subsidy under the notified Scheme in Official Gazette, Series I No. 28 dated 7th October, 2021.

However, provisional approvals granted/issued prior to the issue of this notification and installation, commissioning and grid synchronization completed on or before 31-03-2023 the subsidy shall be disbursed to the beneficiaries as per notified scheme in Official Gazette, Series I No. 28 dated 7th October, 2021.

1.5 This scheme shall come into force from the 1st April, 2023.

1.6 The scheme shall be implemented through Goa Energy Development Agency (GEDA).

2. *Validity of the scheme.*— The scheme will be valid for a period of 03 years from 1st April, 2023 to 31st March, 2026.

3. *Introduction to the scheme.*— 3.1 The Government of India has set the target of achieving 450GW of Renewable Energy in the country by 2030.

3.2 The Ministry of New and Renewable Energy (MNRE), Government of India vide OM No. 318/6/2022-Grid Connected Rooftop dated 02-02-2022 has simplified the procedure of Rooftop Solar Programme Phase-II.

3.3 This revised scheme for promotion of Grid Connected Solar Rooftop systems with NET and Group NET Metering is therefore formulated in order to promote “Grid

Connected Solar Rooftop systems with Net Metering/Group Net Metering” in the State.

4. *Objectives of the scheme.*— This scheme is formulated with the following objectives:—

4.1 To promote Grid Connected Solar Rooftop Installations as per operational guidelines and OM for implementation of Phase-II of Grid Connected Rooftop Solar Programme issued by Ministry of New and Renewable Energy (MNRE), Government of India and its amendments from time to time.

4.2 To provide State Financial Assistance for the Installation of Grid Connected Solar Rooftop system with Net Metering from 1 kWp up to 30 kWp for Residential consumers, 500 kWp for Group Housing Societies/Residential Welfare Association and from 1 kWp to 90 kWp all other applicable type of consumers under this scheme.

5. *Scope of the scheme.*— 5.1 The main scope of this scheme is to promote & popularize Grid Connected Solar Rooftop System in all consumer segments viz. residential, institutional, social, Government, commercial, industrial etc.

5.2 To provide financial assistance for residential, institutional, educational, commercial and industrial sectors.

6. *Subsidy.*— 6.1 The Central Financial Assistance for the residential sector under this scheme shall be provided as per OM issued by MNRE and the operational guidelines for implementation of Phase-II of Grid Connected Rooftop Solar Programme issued by Ministry of New and Renewable Energy (MNRE), Government of India from time to time. The Financial Assistance shall be permissible only if Domestic Manufactured Solar panels (using Domestic Manufactured Solar Cells) are used by beneficiary. However, Financial Assistance will be limited as mentioned in this scheme.

6.2 The beneficiary will have to install solar rooftop systems only through empanelled vendors as per the guidelines of Phase-II of solar rooftop programme and registered under GEDA.

6.3 The State Financial Assistance for the Installation of Grid Connected Solar Rooftop system with Net Metering from 1 kW upto 30 kWp for Residential consumers, 500 kWp for Group Housing Societies/Residential Welfare Association and from 1 kWp to 90 kWp for all other applicable type of consumers under this scheme.

6.4 The subsidy under the scheme is applicable only for installation of solar rooftop systems through Goa Solar Portal & National Portal for Rooftop Solar.

6.5 The proposed capacity to be installed in the State of Goa under the scheme is 20MW.

The subsidy pattern for various types of consumers are as follows:

A. For Residential Consumers:

The State Government shall provide subsidy restricting to 50% for the first 10 kWp and subsidy restricting to 10% beyond 10 kWp upto 30 kWp of sanction load to the Residential consumers based on the benchmark cost provided by MNRE (As per OM issued by MNRE with regards to the admissibility of Central Financial Assistance (CFA) for residential rooftop solar projects installed under Phase-II of Rooftop Solar Programme and its amendment from time to time).

B. For Group Housing Societies/Residential Welfare Associations (GHS/RWA):

The State Government shall provide subsidy of 50% for the consumers of group housing society/residential welfare association, restricted to 500 kWp of sanction load and based on the Benchmark cost provided by MNRE (As per OM issued by MNRE with regards to the admissibility of Central Financial Assistance (CFA) for residential rooftop solar projects installed under Phase-II of Rooftop Solar Programme from time to time).

C. For Educational Institutions:

The State Government shall provide subsidy of 50% for the Educational institutes,

restricted to 90 kWp of sanction load and based on the Benchmark cost provided by MNRE (As per OM issued by MNRE with regards to the admissibility of Central Financial Assistance (CFA) for residential rooftop solar projects installed under Phase-II of Rooftop Solar Programme from time to time).

D. For Commercial, Industrial and other Establishments:

The State Government shall provide subsidy of 20% for the commercial, industrial and other establishments restricting to 90kWp of sanction load and based on the Benchmark cost provided by MNRE (As per OM issued by MNRE with regards to the admissibility of Central Financial Assistance (CFA) for residential rooftop solar projects installed under Phase-II of Rooftop Solar Programme from time to time).

7. Eligibility for availing benefits under the scheme.— 7.1 All the individuals/buildings/houses/educational institutions/industrial/commercial establishments/NGOs which are registered with Panchayat or Municipality having permanent electricity connections are eligible for subsidy under the scheme.

7.2 Benefit under this scheme shall be disbursed on first come first serve basis.

8. Quantum of financial subsidy under the Scheme.— 8.1 The total amount of Financial Assistance shall be restricted to Rs. 36.47 crores only on first come first serve basis.

8.2 Government reserves the right to stop future grants and also modify the financial quantum, so also the conditions of the scheme, depending upon the budgetary provisions made.

8.3 Government also reserves the right to sanction the grant to the GEDA as well as to hold the scheme in abeyance or suspend or cancel the scheme, at any point of time and no claim or appeal or challenge shall lie with any authority or tribunal or court, in respect of this decision of the Government.

9. Pattern of Assistance of the scheme.— 9.1 The GEDA shall be entitled to Government

grants based on the estimate approved by the Government in the Budget Estimate during that financial year for the scheme and will be sanctioned as per the terms and conditions laid by the Government.

9.2 The GEDA shall promote the installation of Grid Connected Solar Rooftop Installations with Net metering system to all the prosumer's by following the needful formalities.

9.3 The State Financial Assistance in the form of Subsidy shall be released upon completion of one month of solar power being injected into the grid.

9.4 The entire amount of the grants should be utilized for the purpose of which it is sanctioned. Any portion of the grant, which is not ultimately required, will be refunded to the Government. After 'utilizing/refunding' the above sanctioned amount, an utilization certificate should be furnished to the sanctioning authority as required under Form GFR-12A.

9.5 The account of the Grantee in respect of this grant should be audited by the Government approved Auditor/Chartered Accountant concerned immediately after the end of the financial year on completion of six months for which the grant is sanctioned. The account of the grants shall be maintained separately and properly from its normal activities and submitted as and when required. They shall be open to a test check by the Controller and Auditor General of India at his discretion.

9.6 The Audited statement of accounts showing the expenditure incurred by the Grantee from the grants should be furnished to the Government as soon as possible after the close of the financial year on completion of six months for which the grant is sanctioned together with a certificate from the Auditor to the effect that the grant was utilized for the purpose for which was sanctioned.

9.7 The performance-cum-achievement report specifying in detail the achievements

made by the grantee with the Government Grants/amount sanctioned should be furnished to concerned department as soon as possible.

9.8 The Audited statement of accounts showing the expenditure incurred by the Grantee from the grants should be furnished to the Government as soon as possible after the close of the financial year or on completion of six months for which the grant is sanctioned together with a certificate from the Auditor to the effect that the grants was utilized for the purpose for which it was sanctioned.

9.9 A performance-cum-achievement report specifying in detail the achievements made by the Grantee with the Government grants/amount sanctioned should be furnished to the Department of New and Renewable Energy annually.

9.10 The grantee Institution must exercise reasonable economy, observe all financial proprietary and the financial rules as issued by the Government from time to time while incurring the expenditure.

9.11 In case of miss-utilization of grants, the amount so miss-utilized shall be recovered from the Grantee Institution.

9.12 The amount remaining unspent out of this grant shall be refunded back to the Government Treasury by challan.

10. *Relaxation of the provisions of the scheme.*— The Government shall be empowered to relax any or all of the clauses or conditions of this scheme in genuine case(s) for sanction of the grant.

11. *Interpretation of the provisions of this scheme.*— If any question arises regarding interpretation of any clause, word, expression of the scheme, the decision about the interpretation shall lie with the Government, which shall be final and binding on all concerned.

12. *Timelines for processing of applications, and release of subsidy.*—

13. *Redressal of grievances and dispute.*— Grievances or disputes if any, arising out of implementation of this scheme, shall be referred to the Secretary, NRE to Government who shall hear and decide such matters and the decision of the Secretary to the Government in this regard shall be final and binding on all concerned:

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Goa hereby makes the following rules to regulate the recruitment to the Group 'C', Non-Gazetted, Non-Ministerial post for the Indian Reserve Battalion, in the Office of Director General of Police, Government of Goa, namely:—

1. *Short title, application and commencement.*— (1) These rules may be called the Government of Goa, Office of Director General of Police, Indian Reserve Battalion, Group 'C', Non-Gazetted, Non-Ministerial post, Recruitment Rules, 2024.

(2) They shall apply to the post specified in column (1) of the Schedule to these rules (hereinafter called as the "said Schedule").

(3) They shall come into force on the date of their publication in the Official Gazette.

2. *Number, classification and the level in the pay matrix.*— The number of posts, classification of the said post and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the said Schedule:

Provided that the Government may vary the number of posts as specified in column (2) of the said Schedule from time to time subject to exigencies of work.

3. *Method of recruitment, age limit and other qualifications.*— The method of recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in columns (5) to (13) of the said Schedule.

4. *Disqualification.*— No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax.*— Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. *Saving.*— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.
